Disbursement Information

Your tuition will be deducted from the financial aid disbursement each semester and any excess financial aid will be deposited into your bank account by way of Electronic Funds Transfer. You will complete an EFT Authorization form on your student portal if you are a first-time borrower at MTSA. Loan Cancellation Procedure

You may cancel any part of the federal loan disbursement you were offered before the loan disbursement date. Once MTSA is in receipt of the loan funds, you have the right to cancel all or part of your loans within 14 days after the disbursement dates (noted above) for the loan period. To cancel any or all of loan funds received, you must confirm in writing the loan(s) and amount(s) you wish to cancel and send the request to *finaid@mtsa.edu*. Should the reduction or cancellation of loan funds create a balance on your account, you will be responsible for the balance due.
